Dear Sir:-

I am in receipt of your letter of the 1st inst., concerning the Quebec First Entry Report on the tanker "ANDROS VENTURE" and I note your remarks.

I think it well to set forth the circumstances of this special case as follows:-

The G.E. Company was not instructed by the Shipyard that this Society's Class was necessary for this installation until late in April 1953. As soon as the G.E.Co. was informed they acted very quickly and gave every possible assistance to the Surveyor by preparing records of all tests carried out up to the date of our joining the survey and by repeating tests where practicable. They also made available all A.B.S. certificates.

When this office was confronted with the situation it was at first felt that the Maltese Cross could not be assigned to the machinery and Mr. Riddell was informed accordingly. However, Mr. Riddell pointed out that the Owners specially desired the Maltese Cross and he requested that if at all possible the Owners' desires should be met. Accordingly every effort was made to ascertain that the tests required by the Rules had been carried out although not witnessed by the Society's Surveyors so that the effects of the Shipyard's lapse could be corrected as far as possible and the Owners' wishes carried out.

It is regretted that contact was not made with the G.E.Co. when the copy of Mr. Riddell's letter of April 1952 was received but it has not been the practice to do this because it is considered undesirable to relieve the main contractors of their responsibility for giving proper instructions to the sub-contractors.



In the special circumstances it is felt that the question of the assignment of the Maltese Cross to the machinery of this vessel could be submitted to the Committee for their favourable consideration.
