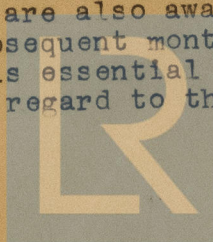

"SINCERE REGRETS AND APOLOGIES YOUR EMBARRASMENTS STOP STILL REORGANISING AND CONTEMPLATING MOVING OFFICE MORE DESIRABLE LOCATION NEAR FUTURE STOP PLEASE ACCEPT MY FORMAL ACCEPTANCE APPOINTMENT NON EXCLUSIVE SURVEYOR EXPLANATION FOLLOWING AIRMAIL".

We await your explanation of the delay in dealing with correspondence etc., but in the meantime we are glad to receive your formal acceptance of appointment as the Society's non-Exclusive Surveyor at Manila.

I take this opportunity to refer to the case of the Motor Tanker "STANVAC VISAYAS II" about which a Classing Letter was sent to you on the 28th October, 1955. Follow up enquiries were made on the 2nd and 22nd December and 10th January, 1956. My cablegram of the 24th January and further letter of the 13th February still remain unanswered. Please be good enough to let me have a reply without further delay. We are also awaiting your Rtn. 5b for December and subsequent months. You will, I am sure, realise that it is essential for us to have up to date information with regard to the ships you have
