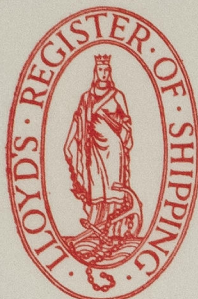

for Docking, Tailshaft and Main Boiler Surveys, whilst in drydock at the Works of Mitsubishi Heavy Industries Co., Ltd., Nagasaki, Japan on the 23rd March, 1966 and subsequently

and that all my recommendations have been carried out to my satisfaction. I am reporting accordingly and recommending to the Committee of Lloyd's Register of Shipping that the machinery classification should be retained and the following survey records assigned TS(CL) 3/66 and MBS 3/66.


Subject to any outstanding condition of class being dealt with as previously recommended.

Parts now examined:—

Docking:— Propeller, aft end of stern tube bush, sea connections (opened out), fastenings, sea inlet gratings.
Wear down of sternbush:— Before relining: 5.0 mm
After relining: 2.2 mm

Tailshaft (CL):— Drawn in, examined, cone end tested by magnetic flux procedure.

MBS:— Port and starb'd main boilers examined throughout with air heaters, superheaters, safety valves, mountings, man hole and hand hole doors, main economizers and fastenings, and subsequently both boilers examined under steam and the safety valves adjusted.
Remote controls examined.
