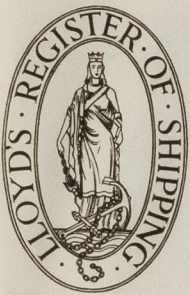

On completion, the above machinery was tried in the shops under working conditions with satisfactory results.
