SHIP'S NAME "MARGIT GORTHON" REPORT Hbg. No. 3350

The remarks of the Chief Ship Surveyor are desired on this case for the consideration of the Classing Committee.

("The endorsement to contain a succinct summary of any repairs that have been required and to show the cause or causes of such repairs, and also to bring out clearly any exceptional features in connection with the case, so that the Classing Committee may have all the salient points presented in the endorsement."—Extract from Sub-Committee's Report, 24/5/62.)

The class is subject to shell plates F.4 & 12 (p.s. from aft) and keel plate No.2 (from fwd) in way of O.F.deep tank being examined and dealt with as necessary also to deck and side shell plating etc. (s.s.) being dealt with as necessary at the Special Survey.

A SPECIAL SURVEY (B) became due 11,58 and postponement until 12,59 was approved 30.11.59.

The Notation "Surveys Overdue 11,58" was assigned 25.3.60.

The HELSINGBORG Surveyors report (3,61) ship examined afloat and in dry dock when the requirements of the Special Survey were carried out together with damage repairs including above subject.

They also report the ship converted to an ore carrier and lengthened in accordance with the approved plans and Secretary's letters.

In view of the above IT IS SUBMITTED the class be amended to ~~LOCAL~~ "Ore Carrier" with record of 'DS 3,61' and Notation 'SS 3,61' assigned, but without special conditions.
