AMINATION AND REPAIRS AS PER RULE FOR Outstanding items to complete S.S., Docking & Class.Dge.

Classification Damage Repairs:

Damage stated sustained on the 16th August, 1960 when on collision with quay in Piraeus. Upon examination found stem bar buckled for about 6 metres and stem plates at 4th, 5th, 6th and 7th strake below sheer set in for 3 frame spaces p. & s. Stem bar now cropped for about 10 metres, faired and welded in place; stem plates, as noted above, cropped and renewed from stem to 3rd frame space from fwd. p. & s. frames p. & s. faired in place.

Conditions of class:

1) S.S. partly held. 2) Indented shell plates J12, H12 & G7, J15 & K14 (ssf) be dealt with as necessary. 3) W.T. bulkhead 28 be stiffened & W.T. door tested. 4) New deck beams inside No. 3 hatchway trunk be dealt with 5) Supports of boat deck extension be fitted. 6) New sewage tank be dealt with. 7) 15 fms. chain cable be supplied. At this time above items dealt with as follows:-

1) SS still not completed; examined windlass and steering gear under working conditions and found them in order; requested to examine overboard discharges & W.T. doors but request not granted; recommended ventilators and air pipes to have closing appliances, O.F. air pipe in tunnel to have wire gauze, load lines to be marked on sides of vessel.

GENERAL OBSERVATIONS, OPINION AND RECOMMENDATION AS TO CLASS

State clearly what alteration, if any, is suggested to be made in the existing Classification or Survey or other records of the Ship in the Register Book consequent upon this survey; for example:—"to remain as Classed in the Register Book without fresh record of Docking"; "to remain as Classed and to have record of drydocking 1,55"; or "to remain as Classed and to have record of drydocking 1,55, and the notation of S.S. . . . 1,55".

This vessel is eligible in my opinion to remain as now classed in the Register Book with fresh record of D.S. 3,61 and to have notation of S.S.(Dr.) 3,60 when the survey is completed, without subject to indented shell plates J12, J13, H12 & G7 and J15 & K14 but subject to set shell plates 2nd and 3rd below sheer s.s. frames 37-40 from aft being dealt with, W.T. bulkhead 28 being stiffened & W.T. door tested, new deck beams inside No. 3 hatchway trunk being dealt with, supports of boat deck extension being fitted, new sewage tank being dealt with, and bulkheads of 2nd class saloon on deck A being specially examined and dealt with as necessary, all by completion of special survey, also subject to 15 fms. of chain cable being applied at earliest opportunity.

2) Shell plates, as noted, specially examined, no indents of any significance now noted and internal structure found in order, except plates at 2nd and 3rd strake below sheer in way of frames 37-40 from aft s.s. found set in, with 4 frames and beam knees buckled; beam knees found strengthened provisionally by connecting damaged frames and beams with 3 x 4" O.A.

3,4,5,6 & 7) Nothing done to comply with our recommendations. It is submitted items Nos. 1,3,4,5,6 & 7 remain in the SRL as previously recommended and item No. 2 be changed to "Shell plates 2nd and 3rd strake below sheer s.s. frames 37-40 from aft set in, to be dealt with by completion of S.S. and a notation be inserted in the SRL Appendix "Indents to side shell p. & s.".

Alteration and new Condition of Class:

On deck A, ends of 2nd class Saloon Lounge, now closed up with plating and wood doors; construction done not under our supervision and no plan submitted; due to panelling now fitted cannot ascertain thickness of plating and scantlings of stiffeners; it is submitted end bulkheads of 2nd class Saloon Lounge on Deck A be specially examined and dealt with as necessary by completion of Special survey.

Indented side shell plating from fwd. F2, J3,4 & 6, H4 & 5 p.s. and H4 s.s.—

Nothing done; examined and found in order and it is submitted this item remains in the Appendix under the general remark "Indents to side shell p. & s.".
