

Dear Mr. Riddell,

For your guidance, in case your records have not yet been revised, the caption vessel has recently been purchased by interests associated with Triton Shipping Inc., 26 Broadway, New York.

The ship is to undergo conversion under a contract which Owners have for three such conversions with Messrs. Cockerill Ougree of Antwerp. The contract was concluded some time ago and the first vessel, the S.S. Lucky Star[†] is the first of the series. On this basis the contracts with the shipyard cover A.B.S. classed vessels and Owners have instructed us to inform you that the 'Esso Flanders' will, under the circumstances, be transferred to that class as a part of the conversion.

We have advised Owners that from a structural point it should not cause any disruption if the class is retained in Lloyds provided that the shipyard would agree to
