## EXAMINATION AND REPAIRS AS PER RULE FOR Docking Survey & SRL repairs.

A number of scattered rivets in bottom port and starboard sides now caulked or welded. One - 6" x 1" steel flat welded to rudder after end to improve steering. Previous rudder-area = 13,73 m<sup>2</sup>. Now rudderarea = 14,64 m<sup>2</sup>. Diameter of rudderhead = 270 mm.

SRL repairs. Shellplate E3 port side in No. 1 hold now cropped in way of web frame and partly renewed, and it is recommended that the special conditions as noted in certificate dated Venice 22nd April 1960 be withdrawn from the ship's class.

The certificate for bower anchor and 15 fathoms cable previously supplied not at head.

It is recommended that this ship be continued as classed with fresh record of DS 9/60, subject to bower anchor and 15 ftms. chain cable (supplied Rotterdam) being verified with certificate earliest opportunity but without special conditions regarding shellplate port side No. 1 hold.
