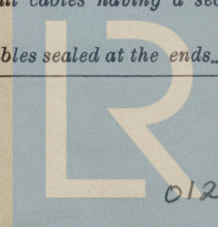

The nearest cables to the compasses are as follows:—

A cable carrying .25 Ampères inside feet from standard compass - feet from steering compass.

A cable carrying - Ampères - feet from standard compass - feet from steering compass.

A cable carrying - Ampères - feet from standard compass - feet from steering compass.
