I have surveyed the above ship in accordance with the Rules for Damage--

Damage alleged to have been sustained on 26th September, 1963 in consequence of striking Pier No. 9 at Maracaibo.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. Found: 2nd & 3rd below sheer, port side in way of No. 4 cargo hold set in over common riveted seam between Fr. No. 66 & 76.

At Maracaibo loose and sheared off rivets had been welded up and cement box installed inside in cargo hold.

At this time some additional rivets were found loose. Cement box was removed and all rivets welded inside and outside as found necessary. Lap seam also made tight by welding.

Upon completion all work hose tested and proven tight.

It is the opinion of this surveyor that vessel is in a fit condition to continue her voyage to Japan where Owner's Representative stated that permanent repairs will be effected.

I recommend that this ship remain as classed ~~with~~ without fresh record of dry docking, subject to damaged shell plating - 2nd & 3rd below sheer and internals in way of No. 4 cargo hold port side being further examined and dealt with as necessary upon vessel's arrival Japan, where she is now bound by way of Mexico.


