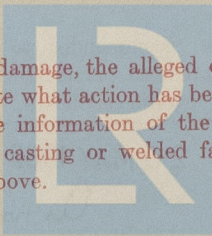
PARTICULARS OF DEFECTS, REPAIRS, ALTERATIONS, ETC.

Tailshaft survey: The working tailshaft now drawn, and checked by magnaflux and found with satisfactory results.

It is considered that its keyway was found in accordance with C 1002 of the Rules, and acceptable for a four yearly examination it so requested by the Owners.

The propeller blades C & D of 4 blades bruised at their tips very slightly, dressed smooth.

The reason for repairs must be stated and those on account of damage, the alleged cause of which must be given, should be detailed separately from wear and tear repairs. State what action has been taken regarding items which are subjects of class. State also where appropriate, for the information of the Technical Records Dept., the material of the defective item and whether it is a forging, casting or welded fabrication. Any alterations in existing particulars in the Register Book should be reported above.
