We thank you for your letter of the 11th ult., regarding the above vessel and your remarks have been carefully noted.

Regarding the points raised we now confirm or clarify as follows:-

- (1) Approved equipment numeral is 99,273.53, as approved by Kobe Office, please see the calculation sheet, forwarded herewith, and we shall be glad if you will kindly return this sheet after your perusal.
- (2)a. As this ship has no dry cargo hold or space, no cargo hatch was provided.
- b. One each small hatch for boatswain stores and provision store were fitted with the following particulars:-

height, secured with hinged steel cover 12.7mm
thick.
