I have surveyed the above ship in accordance with the Rules for Condition Survey.

This ship has the notation - Laid up - Surveys overdue 5/62, in the Register Book.

The ship was drydocked for intended sale and the survey was carried out at the prospective purchasers' request and with the owners consent.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

Items as indicated in the Register Book were generally examined and found in general good condition. It was pointed out, however, that all items would have to be re-examined and dealt with as found necessary for a Special Survey before any fresh survey dates could be assigned.

The ship was subsequently sold and re-named:

"GOLTASTEIN,"

With reference to Secretary's letter Ref. R.JMC/DET of 9th September and Memorandum of 7th October, 1964, the delay in forwarding the report is due to the new owners late decision regarding classification of the ship.

The owners are now converting the ship into a fishing vessel and has decided to withdraw the ship from classification with this Society.
