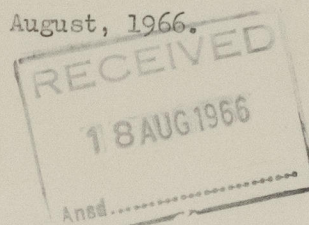

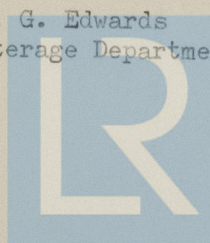
It is our usual procedure for all our vessels, as indeed with m.v. "Charmo", to be built to Lloyds standards and classification, and then after a period, for them to be withdrawn from classification, as we annually slip and overhaul our vessels.

In addition we employ Consultants for both m.v. "Charcrest" and m.v. "Charmo", and arrive at the view that it is not necessary for us to have further safeguards.
