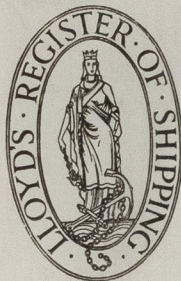

the Owner's Representative attend on board the:-

m.v. "TANDJUNG TORAWITAN", 1712 Tons Gross of Djakarta,

on the 20th July 1959 and subsequently whilst in dry-deck and
afloat at Tandjong Priek, for the purpose of examining without
prejudice, alleged damage, stated to have been sustained on the
13th December 1958 due to grounding on the Laubang Reef.

The following temporary repairs were carried out in January at
Surabaya:-

Mock brackets fitted in No.1 held bilges (s.s) with an external
covering/doubling plate in way of buckled/tern shell plating.
Bilge boys cemented.

On examination the undersigned:-

FOUND:-

Shell plates numbered from ferwd. (stbd. side).

RECOMMENDED:-

No.2 Keel plate set up at aft. end
along stbd. seam

Crop, and aft. section
renew (approx. 4 M)

No.3 keel plate set up at ferwd.
end. along stbd. seam

Crop, and ferwd. section
renew (approx. 5M)

A 2 set up at aft. end

Crop, and aft. section
renew (approx. 10 M) 913

A3 set in/tern at ferwd. end

Crop, and ferwd. section
renew (approx. 4 M)

B 3 buckled/set in at ferwd. end

Crop, and ferwd. section
renew (approx. 6 M)

B4 buckled/set in aft. end

Crop, and aft. section
renew (approx. 3M)

FOUND:-

B5 slightly set in at ferwd. end.

C4 set in between frames

C5 set in/buckled at ferwd. end.

Stbd. bilge keel buckled/
Twisted at ferwd. end

Lower sections of seven floors in No.1 DB tank (s.s) distorted.

Lower section of three floors in No.1 DB tank (s.s) buckled.

No.1 DB tank margin plate distorted along lower edge.

3rd bilge brackets from aft. bulkhead of No.1 Held buckled in way of DB tank margin plate.

4th, 5th, 6th, 7th, 8th, 9th and 10th bilge brackets from aft bulkhead of No.1 Held (s.s) buckled/ torn.

Eleven side frames buckled in way of bilge (No.1 held, s.s)

Two side frames distorted in way of bilges (No.1 held, ss).

RECOMMENDED:-

Release, fair and refit

Seven bilge brackets renew.

GENERAL

Repairs to be water tested on completion.

All material, fittings etc; disturbed in effecting repairs to be put back in similar condition to that before the alleged damage was sustained.

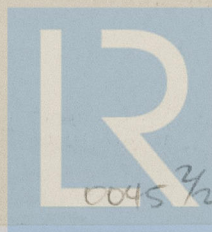
All new and disturbed effected by repairs to be suitably coated.

The foregoing repairs and work incidental thereto, have been carried out so as to place the vessel in the same efficient condition as that before the alleged damage was sustained.
