Damage: as stated to have been caused through heavy weather on voyage from Bombay to New York between the 26th and 27th January, 1966.

Damage situated:

- situated on s.s. shell plating on H,J,L and M-strake frs. No. 94-107
- situated at forward bulwark on bridge deck portside
- situated on forward poopdeck starboardside and adjacent bulwark

Found (a):- shell plating indented on H,J,L and M-strake frs. Nos. 94-107 (s.s.)

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. I recommend, therefore, that this ship remain as classed with ~~XXXXXX~~ fresh record of dry docking 6.66, without condition regarding set in fcle shell plating with internals and bulwark stiffeners and adjacent sheerstrake plating (ss) but subject to any other outstanding condition which may be at present attached to the ship's class being dealt with as previously recommended.

Now Done (c):- buckled poopdeck plate re-inforced by doubling plate (after repairs wood deck was replaced) and bulwark plate (length approx. 6m) with stiffeners renewed.

Docking Survey: now carried out as per attached Rpt.8 (PS)

Repairs: (Wear & Tear):- a few minor items dealt with at this time

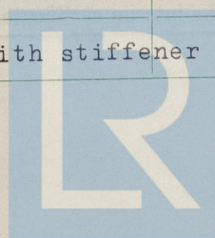
Condition of Class (No. 254):- "Set in fcle. shell plating with internals and bulwarks stiffeners (s) and adjacent sheerstrake plating".

Now Done:- This item now satisfactory dealt with at this time. See damage (a) this report. It is submitted that this item be now deleted.
