PARTICULARS OF DEFECTS, REPAIRS, ALTERATIONS, ETC.

Examined both OF aux.-boilers internally and found to be satisfactory. Whilst floating the safety valves a leakage in the centre furnace of the stbd. aux.-boiler was noted. Centre furnace examined and found several plain tubes badly leaking. As there was no possibility to deal with this matter now, it was stated by the Owners' Representative that the necessary repairs will be carried out at earliest opportunity. It is recommended that the following condition may now be attached to the vessel's class: subject to stbd. OF aux.-boiler plain tubes to be dealt with as necessary and boiler not to be used meantime. Vessel is now proceeding to Le Havre, Surveyors Le Havre have been advised accordingly.

Note: At these aux.-boilers the lugs for anti-rolling stays have been welded direct to the shell plating without pads or doubling plates. The lagging in way of the lugs have been removed and the adjacent shell plating carefully examined and crack detected and found to be satisfactory.

Repairs: (Wear and Tear) Both boiler settings lead lining completely renewed.

The reason for repairs must be stated and those on account of damage, the alleged cause of which must be given, should be detailed separately from wear and tear repairs. State what action has been taken regarding items which are subjects of class. State also where appropriate, for the information of the Technical Records Dept., the material of the defective item and whether it is a forging, casting or welded fabrication. Any alterations in existing particulars in the Register Book should be reported above.
