I have surveyed the above ship in accordance with the Rules for Condition of Class.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

- 1/ Port side scupper valve No.3 tween deck and shell plating in way of now specially examined. Extended spindle control to valve connected and valve placed in open position. The shell plating in way would appear to have been recently renewed, no other defects were apparent and it is recommended that this item be deleted as a condition of Class.
- 2/ Port side Machinery casing locally doubled where thin and wasted. It is submitted this item be deleted as a condition of Class.
- 3/ Load Line marks now cut in, painted and verified. This item to delete as a condition of Class.

Short Term Load Line Certificate valid 6 months issued.

I recommend that this ship remain as classed ~~xxx~~ without fresh record of dry docking and without special condition regarding the port side scupper valve No.3 tween deck and shell plate in way, port side machinery casing and Load Line marks, but subject to any conditions at present attached to the ship's Class being dealt with as previously recommended.
