Motorship "MEGUROSAN MARU"

We acknowledge receipt of your classing letter dated 29th ultimo, in connection with our report No.5921 Report 4b and in reply we have the following comments to make:-

- (1) The particulars of vegetable or similar cargo oil notation in page (1) of our report should read "Carrying vegetable oil in Deep Tanks aft" and not "No" as indicated.
- (2) In the four deep tanks, there are in each tank, one two inch and one three inch bilge suction and not 6-2" suctions as reported.

We regret these errors in our report and we would be glad if this could be corrected and at the same time we would point out that the same error also applies to the sister ships "MUSASISAN MARU" and "MAYASAN MARU".
