Found: Damage situated in way of side shell plating at forecastle (SS)

Permanent Repairs Now Effected:-

Forecastle sheerstrake plate No 2 (SSF) cropped and partly renewed.

Nos. 1 and 2 plates in strake below forecastle

Sheerstrake(SS) from forward faired in place.

Forecastle deck stringer angle cropped and partly renewed (SS)

2 shell frames cropped and partly renewed, 2 shell frames faired in place 1 beam knee renewed, 3 beam knees and 2 beam ends faired in place, all in forecastle space (SS).

2 Sidescuttles removed, overhauled and refitted in way of shell plate repairs.

All repairs hose tested on completion and found satisfactory

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.
I recommend, therefore, that this ship remain as classed ~~with~~/without fresh record ~~of dry docking~~ of Survey
