The remarks of the Chief Ship Surveyor are desired on this case for the consideration of the Classing Committee.

This Cl-M-AV1 ship was built in 1945 and classed with the American Bureau of Shipping.

Classification with this Society is desired.

Plans for this type of ship have been approved at this Office and the scantlings and arrangements found suitable for the class 100A1.

For further particulars of the case see previous endorsements and correspondence.

Provisional Class 100A1 (Classification Contemplated) was assigned 1950.

The class is subject to permanent repairs to bulwarks (p.s.f.) at next drydocking.

The VALPARAISO Surveyor in a First Entry Report and Rpt.8 reports (6,52), the ship placed on a floating dock, the scantlings and arrangements verified, the requirements for Vessels Not Built Under Survey and of a Periodical Special Survey complied with.

The compartments used for oil fuel have been examined externally only (See Circular No. 1871).

The weights of the anchors and length and diameter of chain cable on board are in excess of Rule requirements, and have been tested by the American Bureau of Shipping.

IT IS SUBMITTED the Figure '1' be assigned without the Notation "Lloyd's A & CP".

IT IS FURTHER SUBMITTED the ship is eligible to be classed 100A1 with record of docking 5,52 and the Notation of 'ss.Vpo.5,52'.
