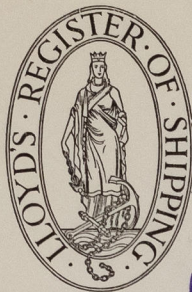

the undersigned Surveyor to this Society did at the request of Messrs. Memphis Shipping Agency, Alexandria, Owners's Agents, and with the consent of the Master, attend on board the

m.s. "BALKAN", 7372 tons gross of Varna,

on the 30th November, 1965 and subsequently whilst the vessel lay afloat at Alexandria, for the purpose of ascertaining the nature and extent of damage stated to have been sustained to  
(1) The No. 1 starboard cargo winch whilst loading at Gardenas (Cuba) on the 25th October, 65.  
(2) the No. 1 port cargo winch whilst loading at Havana on 3rd November, 1965.

For further particulars please refer to ship's Log book.

Upon examination the following damage was found and repairs recommended without prejudice to the terms and conditions of insurance.

## DAMAGE I

### FOUND

No. 1 starboard winch, starb. crankpin noted sheared at landing to crank web.

### RECOMMENDED

Starboard crankshaft to remove and crankpin to renew.

It is stated and now noted that the defective crankshaft was replaced by spare on board.

## DAMAGE II

### FOUND

Drum gear teeth 18 broken (C.I.).

### RECOMMENDED

Drum gear to renew.

Intermediate shaft slightly disturbed.

Intermediate shaft to remove, check on lathe, make good and refit.

FOUND

Cross bar in way of side frames (carrier of clutch handle) bent.

RECOMMENDED


Cross-bar to remove, fair and refit.

The defective drum gear was replaced by spare found on board but repaired temporarily and used as spare until arrival to home port.

The total cost of repairs viz:-

- (1) Repairs to No.1 starboard crankshaft.
- (2) Fitting of the spare drum gear, repairs to intermediate shaft and cross bar.
- (3) Temporary repairs to No.1 starboard defective drum gear.

All amounted to £.225.- (TWO HUNDRED TWENTY FIVE POUNDS EGYPTIAN), this sum is in my opinion fair and reasonable and in accordance with usual charges of Messrs. United Arab Mrt. Workshops.
