compressor journals and bearings.

Starboard main engine scavenge pump.

Port and Starboard main engine scavenge pump driving gears.

Starboard thrust block, shaft and bearings.

Starboard intermediate shafts and bearings.

Holding down belts and chocks.

Port main engine driven lubricating oil pump.

Main engines tested.
