

PARTICULARS OF DEFECTS, REPAIRS, ALTERATIONS, ETC.

A total of 10 plain tubes and 1 stay tube were renewed in the two boilers and opportunity taken to specially examine the front and back tube plate thicknesses in way of the tube holes.

Tube plates remain efficient for the working pressure of 8kg/cm² as noted in the SRL Appendix and the safety valves were adjusted accordingly.
