Messrs. Christof Ruthof, Mainz-Kastel


The Surveyors at Köln have completed the survey during construction of the ferry and waterboat "ZINYAW" built by Messrs. Christof Ruthof at Mainz-Kastel, and before rendering the account we have to say that the scale fees in this case in no way cover the time spent in dealing with the construction and installation of machinery.

The Surveyors made 34 visits, spending 148 hours working time and 131 hours travel time; the expenses incurred being DM 1174.--. The scale fees chargeable would be as follows:-

No fees have been quoted to Messrs. Ruthof and before doing so I feel that the question of an increase of the scale fees should be considered. The present scale of fees for survey during construction of hull and machinery installation does not embody the clause "in cases where the circumstances are unusual or where excessive travel time is involved, fees in excess of the scale may be charged", but this is a case where such a clause would be most helpful.

It is my opinion that in this case at least £250, plus expenses, should be charged, but I should be pleased to have your advice in this connexion.


