Dear Sir,

Visiting Sociedade Geral de Comercio, Industria e Transportes Ltd. at their request yesterday, they advised that they are buying the German S.S. "ARGUS" (Nº. 64432 in the Register Book) having paid a deposit but completion of sale subject to examination in drydock; cost of docking, if any defects found, for sellers, otherwise, to buyers; docking expected at Amsterdam at about end of this month.

Sociedade Geral de Comercio, Industria e Transportes, Ltd. wished to know if the Society would instruct the surveyors at that port to inspect the vessel on their behalf whilst in drydock, advise Owners or their representative of condition of bottom & rudder so that immediate closure of sale can be effected; they also wish the vessel to be classed, with the society, Hull and Machinery, contemplated 100 AL with freeboard & EMC.

Replying to a question regarding cost, I stated, without prejudice, a figure of between £.50 & £.60.

I am of opinion that the "SILVA GOUBEI" will be submitted for classification with the society at the first
