

There is so little to be added to our letters addressed to you on the 8th instant. concerning the above vessels which believe me crossed your telegrams.

Our final letter of the 8th. instant, to the Owners of the "PUNTA MEDANOS" was addressed to the Ministry of Marine, "Direccion General de Transportes Navales", and a copy to the "Direccion General del Material Naval" and in the case of the "BAHIA" vessels to the "Direccion General de Transportes Navales".

Being Naval transports under the jurisdiction of the Ministry of Marine, it seems very definite that they do not desire to retain the classification of these vessels.
