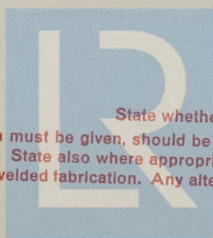
PARTICULARS OF DEFECTS, REPAIRS, ALTERATIONS, ETC.

combustion chamber. Minor wear tear repairs effected.
