I have surveyed the above-named ship in accordance with the Rules for temporary repairs on account of damage sustained in collision with the m.s. "SHIZUOKA MARU", 9364 tons gross, of Tokyo, in Port Said Harbour on the 24th January, 1966.

Damage confined to port side forward shellplating, upperdeck and tweendeck and internals.

Upon examination found: (plates numbered from forward)

Sheerstrake plate No. 1 and forward end of sheerstrake plate No. 2 badly buckled and torn. Shellplate No. 1 in 1st strake below sheer buckled and torn. In way 8 shell frames twisted, partly destroyed. Upperdeck plating in way of stringer plate, 1st and 2nd inboard strake torn and twisted (frames 107 to stem) deckbeams in way including beambrackets affected.

Peak tweendeck stringer plate locally holed and buckled (from frame 167 1/2 to stem)

Bulwarkplating with its stanchion and fittings in way of damaged shellplating torn and badly twisted.

At special request of the Owners it has been agreed to carry out temporary repairs to enable the ship to complete her present voyage.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. I recommend, therefore, that this ship remain as classed with/without fresh record of dry docking survey, subject to damage sheerstrake plate No. 1, and 2 from forward and 1st plate in 1st strake below sheer including decks and structure in way being further examined and permanently dealt with as found necessary by the end of February, 1966 (one month limit).

Temporary repairs now done:

Holed side shell plate No. 1 in 1st strake below sheer and holed peak tween deck closed by fitting a substantial steel cementbox and access hatch to lower peak space closed by strong wooden cover with steel flat bar closing appliances to avoid water entering the lower forecstle space.

The above mentioned temporary repairs have been dealt with to allow the ship to complete her present voyage to a Romanian port for discharging her cargo and it is recommended that the ships class being retained subject to damaged sheerstrake plate No. 1 and 2 from forward and 1st plate in 1st strake below sheer including decks and structure in way being further examined and permanently dealt with as found necessary by the end of February, 1966 (one month limit).

An entry in the S.R.L. for this purpose is submitted.

Items examined found remaining efficient meantime.
