We confirm receipt of your letter of the 8th instant relative to the report of Surveys received^{from} by your Surveyors at Alexandria relative to repairs and surveys carried out at that port between 10th November and 26th December last, for which we thank you.

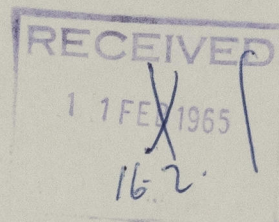
With regard to the list of items requiring attention in consequence of the vessel's Class being continued, we would advise you that item 2 relative to guard rails and the No.2 D.B. tank airpipes port and starboard have been repaired at the port of Constanza last month as promised by the Master to your Alexandria Surveyor, but could not be noted by your Surveyors due to the fact that the Society is not represented in that country.

Regarding items three and four, the vessel is due in the port of Trincomalee about the 15th instant and we are forwarding a copy of your letter to the Master requesting him to contact your Surveyors in that vicinity to inspect these items and also to note the repairs carried out to item two at Constanza.

With regard to item one, defective length of chain cable, it is our intention to renew this cable and we are now awaiting the vessel's arrival at a suitable port to place this cable aboard. When this port is known, your local Surveyor will be notified to inspect same.
