I have surveyed the above-named ship in accordance with the Rules for Damage after stated being sunk on the North Sea due to collision with unknown submerged object on March, 1968.

Damage:-

After being sunk the ship was salvaged and examined on slipway and afloat at the yard of Messrs. de Groot & van Vliet, Slikkerveer. It appeared that the bilge plating at port attend of the hold and engine room was torn open. Bottom and side plating indented and set in. Deck plating locally slightly buckled. Masts bent and rudder with frame probably slightly set over. After negotiations between Owners and underwriters the ship was considered to be a constructive total loss and no further repairs will be carried out.

The ship is now laid up and will be a breaked up in due course.

It was recommended that a suitable notation will be made in the Register Book.

I declare that the items detailed in this report (except as stated otherwise) comply with the requirements of the Merchant Shipping (Cargo Ship Construction and Survey) Rules 1965, applicable to this ship, and are in all respects satisfactory for the service on which the ship is intended to ply namely International voyages/voyages within the limits
