

I James Drummond Shipbuilder in Arbroath Managing Partner of, and for and on behalf of and as authorised by the Arbroath Shipbuilding Company Whereas the said Shipbuilding Company recently built a Barque for Mr Charles Hay Stewart of London now called the "St Elizabeth" which Barque was built under special Survey, and was intended to class for ten years AT at Lloyds and Whereas in consequence of a deviation from the Rules laid down by Lloyds Committee a nine years certificate only was awarded to the said Ship and Whereas on my representation of the circumstances to the said Committee they have agreed to raise the character of the said ship to a ten years Class on condition that Limber strakes of the said vessel are bolted to the floors as prescribed by the said Rules where the first footholds do not meet on the Keel conform to their Secretary's Letter addressed to me and dated the eighth day of November current. And Whereas it is not practicable to have the said Work done at present in consequence of the vessel having part of her cargo on Board and Whereas the said Committee have agreed to accept of my undertaking to do the said work in manner under written Wherefore I the said James Drummond Managing partner foresaid and for and on behalf of and as authorised as aforesaid Do hereby Bind and Oblege myself and the said Arbroath Shipbuilding Company on the first opportunity which presents itself to bolt the Limber strakes of the said Barque "St Elizabeth" to the floors thereof, where the first footholds do not meet on the Keel all as prescribed by Section forty six of the Rules of Lloyds Registry of British and Foreign Shipping and further I hereby Bind and Oblege myself when required to grant any further or more formal Obligation & under such penalty as may be required by the said Committee of Lloyds or their Secretary And I hereby Consent and Agree that this Obligation may be enforced against me by the said Committee or their Secretary and that all execution may follow hereon, at the instance of the said Committee or their Secretary. 
