This vessel placed in dock on account of damage to hull - the shafting was ascertained to be out of line in consequence of which the crankshaft & tunnel shafts have been lifted and bearing adjusted.

The Low pressure cylinder & valve have been overhauled.

Pump links & rods have been overhauled & adjusted.

To facilitate repairs to hull all bilge pipes in engine room were removed also platforms in engine room lifted - These have been satisfactorily replaced.

One extra cushion fitted to Engine room bilges.

General Observations, Opinion, and Recommendation :—
