 Plate round blow off flange - externally - affected by corrosion - Blow off covering plate removed & a new one of large diameter to cover the corroded part has been fitted.

## General Observations, Opinion, and Recommendation :—

The sea cocks & valves, propeller & fastenings are all in good & safe working condition and I am of opinion the machinery is eligible to remain as classed in the Register Book.
