Steel British steamer " Emma ".

At the request of Messrs Loder, Bik, & Rombach, average adjusters at Rotterdam; the undersigned R. Leeuwenburg surveyor to Lloyd's Register, J. de Jong, and A. van Veen, surveyors all at Rotterdam, have attended on board of the S.S. Emma "to inspect and to value the damages sustained in consequence of the efforts to get the steamer afloat and to value the remains of old material; and to value the steamer in her damaged condition:

Declare, that they have inspected the steamer's bottom in drydock; after the discharging of the cargo and after the cleaning of the inside of the vessel they have inspected the holds, bunkers, boiler and engine room, and the decks.-

In want of the captain, engineer, and lookbooks, they have tried to get informations of the salvage surveyor, and salvage foreman; and after having received these informations they have made an other inspection; after which surveys they report as follows:

Broken through the discharging of the cargo, two gaffs; broken through the salvage lighthers, one davit and skid, and damaged through these lighthers one davit and skid, rails and stanchions on the starboardside of bridge deck, the mainmast rigging, two shell plates with angle iron and moulding, and some shell plates slightly indented; two ventilator coamings broken in mooring the salvage lighthers, and four coils of 6" manilla used with mooring the lighthers, one coil of 3" manilla used for guys, and two steel wires of 3" are used with the discharging.-

For tightening the leakages 200 grain bags, two tarpaulings and one sail used and destroyed; some bulkhead planks used in placing the salvage pupms, and with the discharging the steam winches are damaged.-

They value the costs of repairing and replacing the damages as follows:
