Vessel placed upon the slipway. Bottom cleaned, examined, & recoated. It is now in order.  
 Repairs:— A few skull rivets renewed. One length of chaffing bar on port side renewed.  
 2udder pintles renewed & 1 bushed.  
 Ceiling in holds & lining in fore-castle & cabin removed as required & part renewed. The ceiling in the bunks. The peaks, chain locker, fore-castle, fore hold, main hold, cross & side bunks, machinery & boiler spaces, cabin, & transoms, cleaned, examined, & found in good condition. All exposed ironwork in each space cleaned, & coated. The Ballast Tanks, cleaned, examined, cement washed & lined. Cement throughout hold.  
 The decks, pumps, masts, rigging, windlass, steering gear, & connections, examined, overhauled, & parts renewed where necessary. The general equipment examined.
