Now done, yellow-metal stripped, bottom Caulked and yellow-metal renewed on felt. Piece of head reduced in length. Port-side hawse pipe renewed, head fittings partly renewed.

General Observations and Opinion,

Now done, yellow-metal stripped off the bottom except the 5 upper courses, caulking tested and found good, yellow-metal renewed where taken off on felt. Iron damage. Port-side quarter timber scathed with teeth, also stem timber adjacent scathed, rail and stem plating part renewed in way of deck. Partly Caulked where found necessary. He now appears in good condition.
