 The tailshaft liner was found slack at a part which was not bearing. This has been removed and the tailshaft appeared in a good condition.
 Examined 2 main boilers and domes & found them good
 Examined donkey boiler & found it good
 Examined safety valves & found them good. They were found to blow off at 60 lbs.

 (State clearly what alteration, if any, is suggested to be made in the existing notification of the vessel's machinery in the Register Book, consequent upon this survey.)


