 This vessel has been examined in the Royal Albert Dry Dock. Several rivets in the two aftermost frames were found to be leaking and these have been renewed, and the bottom, otherwise found in good order, has been cleaned & painted. Several rivets were also found to be started in the rudder plating and these have been renewed.  
 A new 4 inch steel wire towline has now been supplied.
