REPAIRS, OR EXAMINATION AS PER RULE, FOR Annual Survey.

This vessel was placed on the above-named Pontons when the Bottom which was found in good order was cleaned and re-crested. The Rudder was lifted; the bottom joints of same, ground over, was renewed and the others re-bushed; the Steering gear was overhauled and the vessel, generally, was put in good and efficient condition.

It will be observed that this vessel had changed hands.



This vessel is not, as far as can be seen, in good and efficient condition and I would respectfully submit that she is eligible to remain as classed and to have a new date of Survey 6.92 recorded in the Register Book.
