Examined Main & Donkey Boilers internally & externally & safety valves, also Cylinders, Pistons, Slide Valves, Pumps & Condenser, shafting, propeller Sea & bilge connections and fastenings, all found to be in good condition except the L.P. Piston which was found to be cracked round the cone. Repairs. A new L.P. Piston has now been fitted.

The Safety valves were adjusted under steam.

The tail end shaft was last examined in May 1894. & it was not considered necessary to draw it again at this survey.

General Observations, Opinion, and Recommendation:— This vessel's Machinery is now in good condition & in our opinion the vessel is eligible for record * L.M.C. 5. 95.
