Repairs: A new Propeller now fitted in Place.

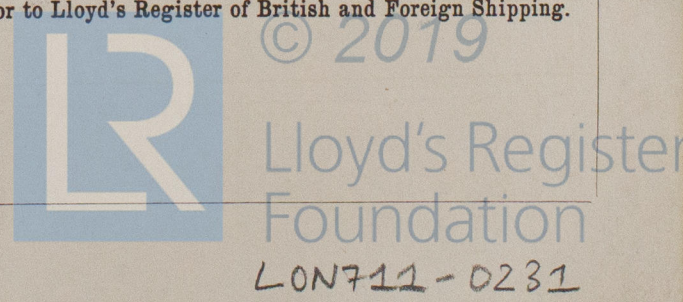
General Observations, Opinion, and Recommendation:—
