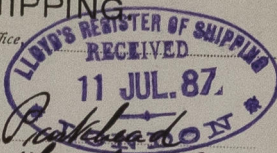

Tests of 330 Steel *bars* manufactured by *Messrs Wm Beardmore & Co* of *Glasgow* for Boiler No. *840* to be constructed by *Messrs J Richardson & Co* of *Hartlepool* for *S.S. No 228* building by *Messrs J L Thompson & Sons*.

The *specified* in the accompanying copy of Advice Notes were rolled from charges. The tensile test has been applied to *eight* samples as set forth below, and the temper and bending tests *to a sample from each bar rolled.*

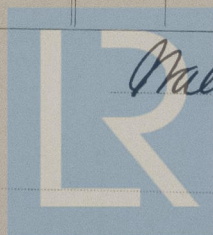
When a second test is applied, the result should be recorded immediately below the record of the original test. The number of plates or bars included in a rejection must be clearly stated.
