We understand that there is no Surveyor there, but no doubt you can arrange for one to be sent from Helsingfors or the nearest place.

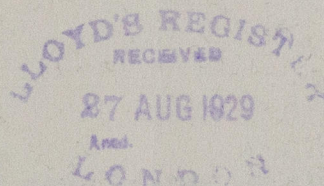

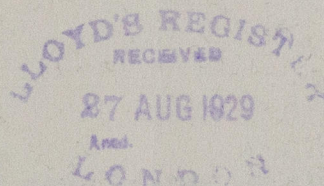
