The class of this vessel was expunged in March 1928 and "Stranded 10,27:In Port Damaged" recorded.

The vessel was examined in dry dock at Genoa in May last when a survey for reclassification was commenced and some repairs recommended.

The Marseilles Surveyors, who were informed that it would be necessary for the requirements of a Special Survey No.3 to be complied with, now forward results of the drilling of the shell plating which are as shewn above (vessel 22 years old.)

Owing to deterioration it is proposed to fit doubling plates






Steel Sc. "TUSCANIA".

to the main sheerstrake in way of the bunkers and deep tank forward of the same, and also to the 2nd strake below the main sheerstrake in way of the deep tank and at the forward end, on port and starboard sides.

It is submitted the plating might be approved provided doubling plates be fitted as proposed, and the Surveyors should be informed by cable accordingly.
