The remarks of the Chief Ship Surveyor are desired on this case for the consideration of the Classing Committee.

("The endorsement to contain a succinct summary of any repairs that have been required and to show the cause or causes of such repairs, and also to bring out clearly any exceptional features in connection with the case, so that the Classing Committee may have all the salient points presented in the endorsement." - Extract from Sub-Committee's Report, 24/5/42.)

The class is subject to the solepiece of the stern-frame, repaired by electric welding and reinforced prior to 8.37, being specially examined at the next dry docking, and to repairs to forecastle side plating, bulwarks etc. (s.s.) being dealt with at the Owners' earliest convenience.

The 3rd Special Survey No. 1 became due 7.39, and after a General Examination in January last the year of grace was granted.

No. 4 plate in 2nd strake below sheerstrake and No. 3 plate in 3rd strake below sheerstrake (p.s.), found indented, require to be dealt with at the earliest convenience.

Action has been deferred for permanent repairs to damaged bow plating etc. on starboard side.

The Antwerp Surveyors now report the vessel placed in dry dock, the bottom coated, and on account of damage through encountering heavy weather 6 shell plates renewed, a shell plate, a deck plate, and some framing in way, repaired and minor repairs effected.

The steering gear has been overhauled and placed in good condition.

The forecastle side plating, bulwarks etc., as above, have now been dealt with.

The requirements of the 3rd Special Survey No. 1 due 7.39 have been complied with, repairs to shell plating, framing,




