We thank you for your letter of the 25th inst. and
would make the following remarks -

S/S "PORT MELBOURNE" & "PORT SYDNEY". We confirm that
the revolutions per minute of the intermediate shafting when
developing a total power of 2,240 I.H.P. in the reciprocating
engine, together with 1280 S.H.P. at the primary pinion, will
be 84. We regret that the revolutions were not included in
our letter of the 17th inst. in the case of these vessels.

S/S "PORT HARDY". We note that the diameter of the
intermediate shafting in the first entry report is 12³/₈" and
not 12⁷/₈" as stated by us. We have confirmed by actual
measurement of the shaft that 12³/₄" is correct and have to

2,040 I.H.P. in the reciprocating engine and 1,160 S.H.P. at the primary pinion, the revolutions of the intermediate shafting corresponding to this total power being 90.5 R.P.M.

We shall be glad if you will kindly confirm as early as possible that these revised figures will be approved.
