

1 Plan in Trip

In the event of any defect due to faulty workmanship or material being discovered in any article supplied by the Company, and being notified to the Company in writing within six calendar months after delivery, the Company will at their option repair or replace such article or articles at their Works or will pay such sum as it would have cost them to repair or replace the same at their Works. Save as aforesaid the Company shall not be under any liability whatsoever in respect of any article supplied by them or any work done by or on behalf of them ; and in any event, and without prejudice to the foregoing generality, the Company shall not be liable for any consequential loss, detention or damage whatsoever or howsoever arising.

If any delay shall occur in the completion and/or delivery of the article or articles through war riots civil commotion malicious damage strikes locks out labour disputes combination of workmen irregular working of men reduction of working hours government interference or control fire tempest, accident, or any other cause of what nature or kind soever beyond the control of the Company a period of time corresponding to that lost by all or any of the above causes shall be allowed to the Company for the completion of their work and the date of completion and/or delivery shall (if necessary) be extended accordingly.
