" All work required by Lloyd's Surveyor has been carried out on the "John Williams V". Plates D7 and D9 portside were renewed and 75 fathom cable is for one side of the ship only. "

We are therefore unable to give you the exact number of visits he made to the vessel but the date of the first visit was the 17th of September, 1947, and the date of the last survey was the 10th March, 1948.


