

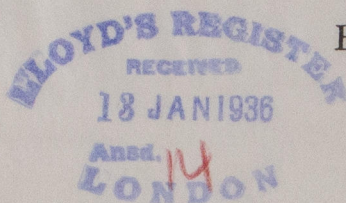

I beg to enclose herewith the freeboard verification form and a copy of the temporary certificate now issued in the case of the Steamer " IRRAWADI ".

New webs -(1) 11" x .5", (2) 14" x .5", & (3) 11" x .5", all angles 3" x 3" x .5" have now been fitted in Nos. 1, 2 & 3 hatches.

New sockets, 3" deep, have been fitted for the fore and afters.

All cleats on No. 3 hatch are spaced the same as Nos. 1 & 2.

The steel storm covers on the fidley gratings are permanently attached by hinges.

There are wood and canvas covers for all ventilator coamings and canvas covers for all air pipes, and all the sanitary discharges are above the freeboard deck.
